*Funeral Arrangements \$395.00
Covers the cost of a licensed Funeral Director to provide professional guidance and facilitate a proper plan for the family's funeral wishes. May include but not limited to personal supervision by a Funeral Director, coordinating activities, rites and ceremonies.
*Documentation: \$305.00
The processing of all necessary legal and professional paperwork may include Statement of Death, Medical Certificate of Death, Cremation and Cemetery documents, Clergy information, Proof of Death Documents, Canada Pension Death Benefit, Cancellation Forms and/or other necessary forms.

Obituary/Website: \$175.00
Includes composition, editing, proofing, scanning and electronic transmission of photo(s) to selected newspapers(s) and funeral websites.

## Transportation of Remains and Vehicles:

*Transfer from Place of Death: \$295.00
Includes all fees necessary for the professional transportation of the deceased. Includes but is not limited to all professional staffing, use of specialized vehicle, specialized equipment, transportation, and cleaning. Please note an additional $\$ \mathbf{1 2 5}$ applies to transfers made outside of Monday to Friday from 9AM to 5PM.
*Transfer to Crematorium/ Cemetery: \$295.00
Includes all fees necessary for the professional transportation of the deceased. Includes but is not limited to all professional staffing, use of specialized vehicle, specialized equipment, transportation, and cleaning.

## Mileage outside Greater Sudbury $\mathbf{\$ 2 . 4 0}$ per KM

This fee applies to any transfer that is over 125 kilometers outside of Greater Sudbury. A rate of $\$ 2.40$ per kilometer one way will be charged.

## Hearse: \$495.00

This fee applies to the use of the funeral hearse which is required to transport the casket during funeral processions or outside the funeral home.

## Limousine: \$250.00 each

This fee applies to the use of the limousine (2 hours) for use in funeral processions which can seat 7 comfortably.

## Lead Car: \$230.00

This fee applies to the use of the lead car which is necessary for all processions which provide special traffic lights and is the vehicle in which the clergy is transported in.

## Service Vehicle: \$195.00

This fee applies to the use of a service vehicle for various uses such as but not limited to transportation of flowers, delivery of paperwork or transportation of equipment.

## Travelling Equipment and Set Up: \$175.00

This fee includes the use of equipment such as Candles, Crucifix, Kneeler, use of casket carriage, use of flower stands, for residential casket set ups, out of town/church casket set ups or use of cemetery device for casket.

## Basic Preparation: \$225.00

This fee may be beneficial when someone may wish the deceased to be viewed or at the wish of the purchaser. This may include, washing, setting features, and/or dressing the deceased, but does not include the embalming of the deceased. This must be done by a licensed funeral director.

## Embalming: \$695.00

The temporary restoration, disinfection and preservation of the body. This includes cosmetics, dressing and placing of the body in casket. Although it is not required by law, it is our suggestion to present an embalmed body for public viewing.

## Facilities:

## *Fundamental Overhead Costs: \$390.00

Covers basic operational cost of Funeral Home including; property taxes, heat, lights and other operational costs.

## *Facilities for Sheltering Remains: $\mathbf{\$ 9 0 . 0 0}$

A room not available to the public set aside in the funeral home where your loved one is kept until paperwork is complete or period before visitation. This fee includes 72 hours of sheltering but may be increased depending on circumstances such as weekend and or holidays. Please note after 72 hours we charge $\mathbf{\$ 5 5 . 0 0}$ per day.

## Facility to Identify Deceased: \$375.00

Includes the use of the room and staff for one hour for the purpose of identification only. Does not include public visitation.

## Facilities for Visitation: \$585.00

Includes the use of the facility for the purpose of visitation for 2 hours which includes but is not limited to room set up, use of religious equipment, floral set up, use of fellowship room for beverages (coffee, tea and juice included), cleaning of room and use of television, DVD or multimedia equipment. Additional hours are available for $\mathbf{\$ 1 0 5 . 0 0}$ per hour, which include staff.

## Staff Services for Visitation: \$185.00

Includes the staffing necessary for the visitation for direction of guests, receptionist for donations, coat check, coffee room attendant.

## Facilities for Ceremony: \$450.00

The use of the Chapel or visitation room for the funeral, memorial or prayer service. This fee applies to all locations and may include but not limited to use of religious, equipment, audio equipment and service recording.

The Provider may receive remuneration from the trustee, not based upon this individual investment, but rather on the Provider's overall activity with the trustee.

## Permitted Amount:

On or after the 31st day after the day on which the Prepaid Contract was made, the Provider may retain $10 \%$ of the Prepaid Contract price (or amount paid, whichever is lower) up to a total maximum of $\$ 350.00$. This amount need not be invested in trust and if retained, is a credit against any amount the Provider may retain if this contract is cancelled.

## Value of Trust Once per Year:

Once in a year, if the Purchaser requests, the Provider will provide information about the amount in trust and how it is invested. If the money is in an individual trust account, the Purchaser will receive a statement that sets out: the current value of the account(s) as of the end of the month before the request, the name of the depository, and the name or type of investment in which the payment(s) have been placed.

## Fulfilling this Prepaid Contract and Excess Funds - Trust:

At the time the services and supplies are provided, the price of the supplies and services provided under the Prepaid Contract will be calculated on the price list in effect at that time, and the actual disbursements, if included in the Prepaid Contract and prepaid, and applicable taxes will be added.

If this Prepaid Contract has been paid in full in accordance with the terms of payment, the payment required under the Prepaid Contract, plus the income earned, will be applied to the cost of the services, supplies, disbursements and applicable taxes. If the payment(s) and income earned are less than the cost of the services, supplies, disbursements and any applicable taxes included in the Prepaid Contract, no further payment will be required. Increases to taxes or fees imposed by Federal, Provincial or Municipal Governments now or in the future may be owing in addition to the payment(s) and income earned.

If the payment(s) and income earned are more than the cost of the services, supplies, disbursements and applicable taxes, the excess amount will be paid to the person entitled under the Prepaid Contract to receive the payment.

## Substitution:

The Provider will make reasonable efforts to obtain and provide the services and supplies agreed to in this Prepaid Contract. If the Provider and person entitled to cancel this Prepaid Contract agree, the Provider may substitute a supply or service, which will be of comparable quality and value, and similar in style, design and construction to, the supply or service that is unavailable. The substitution will be made at no increase in price. If the Provider is unable to obtain and provide a service or supply, the Provider will provide a refund of the sum of the initial amount paid for the supply or service and any income earned on the amount paid. The Provider will inform the person entitled under this Prepaid Contract to cancel this Prepaid Contract, of the refund. This Prepaid Contract may be cancelled in accordance with the terms of cancellation.

## Warranties:

The Provider warrants that it will provide the services agreed to in this contract to the best of its abilities. The warranties granted in connection with the supplies provided as part of this Prepaid Contract are the expressed written warranties, if any, extended by the manufacturer of such supplies, and as required by Ontario consumer protection legislation.

## Cancellation Rights:

## Lougheed's Limited

The Purchaser, or someone designated in the Prepaid Contract by the Purchaser, may cancel this Prepaid Contract by providing notice of the cancellation in writing to the Provider. A partial or full refund of money paid, if any, may be available based on the terms of the Prepaid Contract and the law. Any refund owed will be issued within 30 days.

If the Prepaid Contract meets all of the requirements of the Act and is cancelled within 30 days of this Prepaid Contract date and before any services or supplies have been provided, the Provider will refund all amounts paid under this Prepaid Contract in accordance with the Act.

If this Prepaid Contract meets all the requirements of the Act and is cancelled after 30 days, and some of the services or supplies have been provided as directed under the terms of the Prepaid Contract, the maximum refund required will be the amount paid under this Prepaid Contract plus any income earned on the amount paid or that should have been earned on the amount paid if it had been deposited as required, and in some circumstances permitted by the Act, the Provider may retain the value of the services and supplies that have been delivered.

If this Prepaid Contract fails to meet the requirements of ss.40(1) of the Act, the maximum refund required will be the amount paid under this Prepaid Contract plus income earned on the amount paid or that should have been earned on the amount paid if it had been deposited as required. In some circumstances permitted by the Act, the Provider may retain the value of the services or supplies that have been delivered.

The following individuals may cancel the Prepaid Contract and receive the refund before the services or supplies are delivered.

1. Before the death of the Recipient, the Purchaser or a person designated in the Prepaid Contract by the Purchaser may cancel this Prepaid Contract at any time and receive the refund.
2. Before the death of the Recipient, but after the death of the Purchaser, the Recipient or the Recipient's personal representative or a person designated in this Prepaid Contract by the Purchaser may cancel this Prepaid Contract at any time, and the Recipient is entitled to receive the refund.
3. After the death of the Recipient, the Recipient's personal representative or a person designated in this Prepaid Contract by the Purchaser may cancel this Prepaid Contract at any time prior to services being fully performed, and the Recipient is entitled to receive the refund.
4. If the Prepaid Contract is not fully paid within 12 months of the date the Prepaid Contract is signed, this Prepaid Contract will be null and void unless otherwise directed. The Provider will continue to hold the funds in trust, returning at the death of the Recipient all trusted funds and interest to be used as an "at need" cost.
5. Should the estate trustee at the Recipient's death, cancel any portion of this Prepaid Contract, it shall have the same effect of cancelling the entire Prepaid Contract at the discretion of the Provider.

## Rental Caskets:

By their nature, rental caskets are used a number of times. When a rental casket is used the insert is replaced after every use.

## Possession of Cremated Remains and Refundable Deposit:

The Purchaser authorizes the Provider to take possession of the cremated remains of the recipient from the crematorium. The Provider will retain the cremated remains for no more than one year from the date of cremation. If the cremated remains are not claimed within one year, the Provider will make reasonable effort to contact the purchaser and advise of their options or the Provider may inter the cremated remains in a cemetery, including in a common lot for which the cemetery is the interment rights holder, and the Purchaser will pay all costs of the interment or subsequent storage charges. The funeral home may require a refundable deposit in the event that human remains are unclaimed, this amount is $\$ 350.00$. It is not the practice at our Funeral Home to require this deposit.
